

<sup>^</sup>Each business center that qualifies for Luxury Level I or Luxury Level II earns admission for two to Global Top Achievers 2019 and a four-night standard room at a hotel Isagenix chooses in Nassau, Bahamas. Each business center that qualifies for Global Top Achievers Luxury Level IV receives an invitation for two and may purchase admission to Global Top Achievers 2019 for \$750 per attendee. This fee is solely for admission to Global Top Achievers 2019 and does not include flights, ground transportation, or hotel accommodations. Admission includes access to social events only.

Only the Associate listed on the business center and that Associate's spouse or business partner listed on the account, by the end of the qualification period, will be eligible to attend General Session.

ADDITIONAL GUESTS OVER 18: Each business center that qualifies for Global Top Achievers 2019 may purchase admission for up to one (1) additional adult guest by paying a \$750 fee.
