HOW IT WORKS

We'll look at what your recognition rank was at **11:59 p.m. ET Sunday, July 12, 2020**. You'll be able to earn any Crystal bonus and rank above that!

For example, if you are a Manager or Crystal Manager at 11:59 p.m. ET July 12, 2020, you can earn the Crystal Director bonus of US\$750 and the Crystal Executive bonus of US\$1,000.

Executives and Crystal Executives have the opportunity to earn all the Crystal bonuses again by developing new Consultants!

"Crystal Reset" is based on the qualifications of "Rank Advancement Bonuses Promotion".

you can earn a:

US\$1,000 bonus & Crystal Executive status by Jan 9, 2021

Executive or Crystal Executive

you can earn a:

US\$250 bonus & Crystal Manager status by Sep 11, 2020

FAQ

Q: Do my Consultants have to be new Consultants, or can I reactivate old Consultants?

If you are earning your Crystal Manager, Director or Executive bonus for the first time, you can reactivate Consultants or develop new ones. If you are an Executive earning the Crystal Bonuses again, you must develop new Consultants.

Q: What is my recognition rank?

Your recognition rank is the highest rank you've ever achieved with your Isagenix business. You can see your recognition rank on the left-side panel on the homepage of your Back Office.

Q: What is my 1PET?

1PET is the first level of your Personally Enrolled team. Personally Enrolled means you helped someone open a membership account with Isagenix — as a Preferred Customer or Associate, they are considered your Personally Enrolled Member and are assigned a place on your Team Placement Tree — on either your Left Sales Team or your Right Sales Team.

Q: What is a Consultant, and how do I become one?

Become a Consultant by accumulating 100 PV and maintaining a minimum of 100 BV from Personally Enrolled Associates on each of your Left and Right Sales Teams, all within the past 30 days.

Q: What do I need to do to earn the US\$250 Crystal Manager bonus?

Have at least two Paid-As Consultants in your 1PET any day on or before Sep 11, 2020.

Q: What do I need to do to earn the US\$750 Crystal Director bonus?

Have at least six Paid-As Consultants in your 1PET any day on or before Nov 10, 2020.

Q: What do I need to do to earn the US\$1,000 Crystal Executive bonus?

Have at least 10 Paid-As Consultants in your 1PET any day on or before Jan 9, 2021.

Q: I'm a current Executive, am I required to develop 5 Consultants on my left team and 5 Consultants on my right team to earn the Executive bonus again?

No. You can develop Consultants on either the left team or the right team to earn the Executive bonus again.
